### Expertise

Mr. Kronauer specializes in all matters of tax advice for corporations, in particular bank financing transactions, domestic and cross-border M&A (including corporate reorganisation), equity capital market transactions, ABS transactions and capital market products, including collective investment schemes and charitable institutions. He advises individuals in all matters of tax law, in particular transfer of domicile, lump sum taxation, real estate transactions, inheritance tax and ongoing income and wealth taxes. Recently, he further focuses on international administrative assistance in tax matters proceedings.

He has devoted a substantial amount of time to advising banks, issuers and sophisticated investors (including private equity and sovereign wealth funds) on Swiss taxes in high profile equity transactions. Recent instructions from clients comprise IPOs, rights offerings, innovative hybrid financing deals and a variety of securitisation transactions.

He frequently advises borrowers and lenders on Swiss taxes of debt products through the credit spectrum, for example on ABS-transactions, EMTN programs, bond issues, structured finance transactions and loan facilities for general corporate purposes, public bids, private acquisitions, asset and leveraged finance.

Mr. Kronauer regularly advises domestic and international issuers of structured products on the Swiss taxes and is negotiating the tax treatment of new products with the tax authorities for such issuers.
