Dr. Boris Catzeflis is a Swiss qualified attorney-at-law driven by a passion for innovation bringing a specialized legal and business expertise in the life sciences, TMT/ICT and space industries.

He regularly advises Swiss and international clients on technology and IP transactions, R&D collaborations, PE and VC deals, regulatory matters (telecommunications, data protection, etc.), corporate governance, M&A and business matters and disputes, with a particular focus on drafting, reviewing and negotiating complex technology and commercial contracts.

Recent matters in which Boris acted include:

- drafting IP licensing agreements (patents, software, trademarks, know-how, likeness, etc.) for pharmaceutical, biotech, medtech, satellite, robotics, SaaS, cloud and AI companies, and advising in connection with the use of open-source licenses;
